For the 26th time in the last 27 years, WAEPA was proud to issue a 10% premium refund to all members whose insurance was in-force by December 31, 2021 and continued through August 31, 2022. Although these refunds are not guaranteed, WAEPA has refunded over \$100 Million to its members since 1996.

I also want to thank all of you that joined us on October 20th for WAEPA's 2022 Federal Summit and Annual Member Meeting. Whether you came to listen to Joe Theismann's inspirational keynote speech or to get advice from our panel of esteemed federal benefits experts, it was a truly memorable event.

2023 Scholarship Program

APPLICATION NOW OPEN.

Every year, WAEPA proudly provides tuition assistance for up to 90 individuals. Since 2007, we've awarded over \$2 million in scholarships to children of our members.

If you have a Group Term Life or Short-Term Disability Insurance policy, your child is eligible to apply. All applicants must be under the age of 23 and maintain a minimum grade point average of 3.0 on a 4.0 scale (or its equivalent).

This year's available scholarships include:

- 80 scholarships of \$2,500 for students attending four-year colleges or universities
- 10 scholarships of \$1,250 for students attending two-year colleges or vocational-technical schools.

Thursday, February 2 at 4 p.m. ET.

EXCLUSIVE OFFER: Add \$150k of Life Insurance Coverage with no Medical Underwriting**

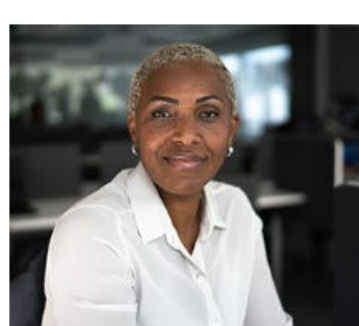
